ARTICLES OF INCORPORATION

ARTICLE I

NAME AND REGISTERED OFFICE

- 1.1 Name. The name of the corporation shall be MISSION CENTRAL, Inc.
- 1.2 Registered Office. The location and postal address of the initial registered office of the corporation in this Commonwealth is 5 Pleasant View Drive, Mechanicsburg, PA 17050

ARTICLE II

PURPOSE AND TERM

- 2.1 Purpose. The corporation is organized exclusively for charitable and educational purposes, under section 501(c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, to engage in activities that provide material aid and support, on a local, national and global basis, to persons in need and, in particular, those who are the victims of major natural disasters.
- 2.2 No Pecuniary Profit. The corporation does not contemplate any pecuniary gain or profit, incidental or otherwise.
- 2.3 No Personal Benefit. No funds of the corporation shall insure to the benefit of, or be distributed to, its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article II.
- 2.4 Restrictions. No substantial part of the activities of the corporation shall be devoted to the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

2.5 Activities Not Conditional. The corporation shall not make adherence to, or profession of, any particular religious faith, creed or belief as a condition of receiving aid and support from the corporation.

2.6 Term. The term for which the corporation is to exist is perpetual.

2.7 Compliance with Federal Tax Code. The corporation shall not carry on any activity not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding section of any future federal tax code or a corporation, the contributions to which are deductible under Section 170(c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding section of any future federal tax code.

ARTICLE III

MEMBERS AND STOCK

3.1 Non-Stock Basis. The corporation is organized upon a non-stock basis.

3.2 No Members. The corporation shall have no members.

ARTICLE IV

DISSOLUTION

4.1 Priority of Distribution of Assets upon Dissolution. Upon dissolution of the corporation, all the assets of the corporation shall be distributed to the Susquehanna Conference of the United Methodist Church or any successor thereto, if at the time of dissolution, the Susquehanna Conference of the United Methodist Church, or its parent denomination or the successor of either is a 501(c)(3) corporation within the meaning of the Internal Revenue Code, unless the conference declines to accept the assets of the corporation.

4.2 Distribution of Remaining Assets upon Dissolution. Any assets as to which the Susquehanna Conference of the United Methodist Church or any successor thereto declines to receive from the corporation, such remaining assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding section of any future federal tax code.

4.3 Changes to this Article IV shall require the affirmative approval of two-thirds of the voting Directors then in office.

ARTICLE V

INCORPORATOR

5.1 Incorporator. The name and postal address of the incorporator is The Susquehanna Conference of the United Methodist Church, 303 Mulberry Drive, Mechanicsburg, PA 17050.
